**Cpl Healthcare and Chesham are pleased to announce that Ireland's national public health and social care provider, the Health Service Executive (HSE) is recruiting for Physical Therapists to work in a range of services including primary care/community, acute hospital and pediatric disabilities services on a nationwide basis across Ireland. Positions will be available in adults and pediatric services. These positions are approved for filling by the Department of Migrant Workers and are open for immediate applications**

**MANDATORY APPLICATION REQUIREMENTS:**

- Must be a graduate from a four-year Bachelor of Science in Physical Therapy program from a leading recognized University.
- Must possess a Professional Regulations Commission license to practice as a Physical Therapist.

- Post qualification experience must involve working in a Physical Therapist led service, as part of a team of Physical Therapists as well as other multi-disciplinary team members, for example, Doctors, Nurses, Dietitians, Occupational Therapists, Speech and Language Therapists, Social Workers etc.
- Must have 2-3 years post-qualification experience in a patient facing healthcare setting, for example, in acute care hospital, primary care/community service, rehabilitation service and/or disabilities service.
- Must be currently working and have continuously worked as a Physical Therapist for the past two years. Candidates out of relevant professional practice for more than two years cannot be considered.
- No candidate will be deployed to Ireland without CORU registration.
- Applicants for this position must possess CORU (Health and Social Care Professionals Council, Ireland) registration or be working towards its acquisition by firstly applying for recognition of your qualifications. - There is no requirement outside of the CORU registration process regarding the possession of IELTS. Therefore, should CORU grant you an exemption from IELTS, for example based on a letter of justification from your university, there will be no further need to take this test.
- One requirement of CORU registration is that applicants for registration must have completed a minimum of 1,000 hours in practice placements which must include the following core areas: musculoskeletal, neurological and cardiorespiratory physical therapy and expose to patients across the lifespan. The clinical placement hours will need to be signed off by a licensed Physical Therapist.

**If you cannot verify such placement practice experience, your application cannot be considered.**

- Must have the ability to undertake assessments of patients independently.
- Must have experience in making clinical decisions independently.
- Must have the ability to collect and report on data.
- Must be capable of working independently (most HSE roles will be in the community, after completing an induction period).
- The possession of a Philippine car driver's license will be an advantage.

- **The HSE is offering contracts of a minimum of 2 years with the opportunity for permanency up to retirement age.**
- **A basic annual salary of €40,325 - €58,483 depending on experience.**
- **A very generous relocation package to the value of €4,710 for flights and accommodation allowance.**
- **Free airline ticket from Manila to Dublin and return, upon completion of initial 2-year contract, if the candidate is leaving the assigned hospital or HSE employment.**
- **Reimbursement of DMW processing costs to \$169 for deployed candidates.**
- **Reimbursement of CORU recognition and registration costs to €510 for deployed candidates.**
- **Critical Skills Employment Permit ('CSEP') cost of €1,000 paid by the HSE.**
